TEACHING EXPERIENCE

Teaching Fellow: PHIL 204 (‘Life, Death, and Meaning’) Philosophy Department, Queen’s University, Kingston, ON
Fall 2019

- This course will examine a range of texts—ancient and contemporary—which discuss the question of meaning in life.

Teaching Assistant: PHIL 296 (‘Animals and Society’) Philosophy Department, Queen’s University, Kingston, ON
Winter 2018

- This course introduces students to historical and contemporary debates regarding the treatment of nonhuman animals within Western societies, and explores our ethical responsibilities toward them. The course examines a range of human- animal relations, involving domesticated, working, research subjects and wild animals.

Fall 2017

- This course focuses on contemporary work on the nature of moral responsibility. Questions considered include responsibility for attitudes, the nature of blame, the relevance of personal history to a person’s blameworthiness, the difference between being and holding responsible, and whether moral ignorance is at least a partial excuse for morally wrong conduct.
